The Utah Poison Control Center is a 24-hour resource for poison information, clinical toxicology consultation and poison prevention education. Established in 1954, the UPCC has responded to more than 1,000,000 calls for assistance. The UPCC is a program of the University Of Utah College Of Pharmacy, University of Utah Health Sciences.

The Utah Poison Control Center offers telephone stickers, magnets, pamphlets, and emergency action cards for poison education activities in your community. You are also welcome to duplicate our materials, although we ask that you copy the materials in their entirety and please let us know if you decide to do so.

Duplication Guidelines:

- Permission is given to copy the materials, provided that no changes are made in the text.
- If there are any additions to the text, such as a logo, permission must be requested in advance.

Distribution Guidelines:

- Permission is NOT given to sell any Utah Poison Control Center materials.
